

BACKGROUND

The North Carolina State Education Assistance Authority (NCSEAA) is the state agency charged with administering inter-institutional programs of student financial assistance, created by state and federal law, as well as private resources, designed to help North Carolinians meet the cost of higher education. One key responsibility of the Authority is to ensure that State funds are spent in accordance with the purposes for which they were appropriated and the rules that govern their administration.

SCOPE AND METHODOLOGY

The North Carolina State Education Assistance Authority conducted a program review that included, but was not limited to, the following areas:

- Eligibility
- Disbursements and refunds
- · Records and reports
- Fiscal responsibility

The information used in this report was collected through the review of student records, reports and institutional policies and procedures to evaluate relevant institutional business processes; as well as, interviews with institutional staff members. The program reviewer randomly selected student record files for review. The personal identifying information of the sample students reviewed have been excluded from this report and replaced by identifying numbers.

This report documents the findings, if any, for each program reviewed. The details related to the finding were shared with the appointed designee prior to the release of this report. Although the review was thorough, it is not necessarily all inclusive. Consequently, there may be matters of noncompliance that are not identified by this report. In areas of non-compliance, the NCSEAA will work with the institution to establish a corrective action plan that will strengthen the institution's capacity for compliance with program statutes and rules. The program review identifies and quantifies any institutional liabilities in which the institution must return the funds as appropriate.

FINDING

OBJECTIVE 1: TO DETERMINE THE REQUIREMENTS FOR ELIGIBLE STUDENTS TO RECEIVE UNC CAMPUS SCHOLARSHIPS ARE IN COMPLIANCE WITH LAWS AND REGULATIONS

Finding #1: Need to Improve Internal Controls for Student Eligibility Requirements

Eligible Students must be a resident of North Carolina as provided by the UNC Campus Scholarships Program Rules. The Rules Governing the UNC Campus Scholarships can be found at: http://www.ncseaa.edu/documents/UNCCampusScholarshipsStatute.pdf.

During the desk program review:

• One UNC Campus Scholarship recipient was identified from the program review selection as failing to be enrolled full-time and two UNC Campus Scholarship recipients were identified from the program review selection as failing to meet the institutionally-established program specific GPA requirement based on the documentation provided by the Institution.
