

**WINSTON-SALEM STATE UNIVERSITY  
MINUTES OF THE BOARD OF TRUSTEES CALLED MEETING  
FRIDAY, MAY 4, 2018  
DRAFT PENDING BOARD APPROVAL**

Chairman Harris called the meeting to order at 10:07 a.m.

**CONFLICT OF INTEREST STATEMENT**

Chairman Harris read the following statement:

performance, or condition of appointment of a public officers, or employee, or prospective public officers or employee under N.C. Gen. Stat. 143-218.11(a)(6).
